Registration Procedures:

Complete the application and return it with the following deposits: \$200 for Fall preschool classes (pay in full for Fall Stay & Play Class) and \$100 for summer camp. The summer deposit is non-refundable after March 5, 2010. The preschool deposit is non-refundable after April 2, 2010. A \$50 administration fee for each deposit will be retained by Fairmount Temple before these dates.

*******The actual registration for the Pre-kindergarten Enrichment Programs (Challenge, ABLiteraCies, Mini-Challenge and ArtSmarts) will be in April 2010.*******
